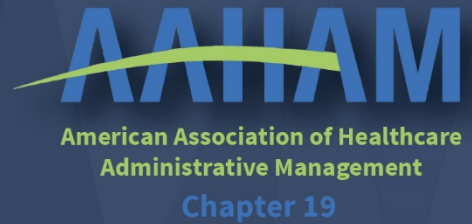

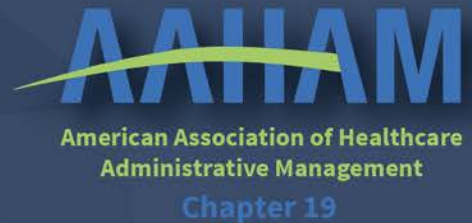

DIRECTIONS

From Wilkes-Barre Scranton Airport

Take interstate 81 South to the Wilkes-Barre exit #170B, then get off at Exit #1, at light turn left onto Route 315 North. The Woodlands will be 1/2 mile on the right-hand side.

From Philadelphia

Take Northeast Extension of PA Turnpike North to Exit 105. Turn left onto Route 115 North. Go 5 miles to Exit 1. Make left at light (315) and The Woodlands is 1/4 mile on the right.
